Associate members may sail their own iceboat and/or sailboard at ISC.

First Year of Membership Dues Structure

Pay one twelfth (1/12) or all of the initiation fee and one twelfth (1/12) or all of the annual dues with the submittal of this form. If the initiation and dues fees are not paid in full for the year when the application is submitted, the Office Manager will bill you quarterly, with the rest of the Club's quarterly invoicing, for your initiation fee and annual dues. Membership applications cannot be processed without initial payments.
